## FINAL JUDGMENT

THIS CAUSE came for hearing on the Motion for Final Judgment of Plaintiff, NOVASTERILIS, INC., whose address is 3109 N. Triphammer Road, Lansing, New York 14882, against Defendant, SURGICAL TISSUE NETWORK, INC., whose last known address is 775 Warner Lane, Orlando, Florida 32803 and whose employer identification number ends in the last four digits of 2608, and Defendant, ALAN J. NOVOTNY, whose last known address is 1250 College Pt., Winter Park, Florida 32789, and whose social security number is unknown. Upon consideration of the Motion, the pleadings and matters of record filed in this matter, including the defaults entered against Defendants and the previous Final Judgment as to Count I, and being otherwise fully advised in the premises,

## IT IS ORDERED AND ADJUDGED as follows:

- 1. Plaintiff's Motion for Final Judgment is **GRANTED**.
- 2. As to Count I, Plaintiff, NOVASTERILIS, INC., shall have and recover from Defendant, SURGICAL TISSUE NETWORK, INC., and Defendant, ALAN J. NOVOTNY, the sum of \$90,987.24 for loss of use damages, and costs in the sum of \$925.65 making a total of

\$91,912.89, which shall bear interest at the statutory rate, for which let execution issue.

- 3. As to Count II, Plaintiff, NOVASTERILIS, INC., shall have and recover from Defendant, SURGICAL TISSUE NETWORK, INC., the sum of \$120,603.34 for breach of contract damages, \$16,597.50 for reasonable attorney's fees with costs in the sum of \$925.65 making a total of \$138,126.49, which shall bear interest at the statutory rate, for which let execution issue.
- 4. As to Count III, Plaintiff, NOVASTERILIS, INC., shall have and recover from Defendant, SURGICAL TISSUE NETWORK, INC., and Defendant, ALAN J. NOVOTNY, the sum of \$6,432.48 for damages for fraud, and costs in the sum of \$925.65 making a total of \$7,358.13, which shall bear interest at the statutory rate, for which let execution issue.
- 5. Judgment debtors, SURGICAL TISSUE NETWORK, INC. AND ALAN J. NOVOTNY, shall each complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet) filed simultaneously herewith, including all required attachments, and serve it on the judgment creditor's attorney, Mark F. Ahlers, Fishback Dominick, 1947 Lee Road, Winter Park, Florida 32789, within forty-five (45) days from the date of this Final Judgment, unless the Final Judgment is satisfied or post-judgment discovery is stayed.
- 6. In accordance with the one satisfaction rule or to otherwise prevent double recovery, the net amount received by Plaintiff for loss of use damages as set forth in paragraph two (2) above from Defendant, ALAN J. NOVOTNY, shall be credited towards and set off the amount due and owing from Defendant, SURGICAL TISSUE NETWORK, INC., for breach of contract damages as set forth in paragraph three (3) above.
- Except as modified herein, the Final Judgment as to Count I entered on November
   3, 2015, remains in full force and effect.

8. Jurisdiction of this case is retained to enter further orders that are proper to compel judgment debtors to complete Form 1.977, including all required attachments, and any other discovery in aid of execution.
