AMENDMENT NO. 1 TO NOTE AND LOAN MODIFICATION AGREEMENT

THIS AMENDMENT NO. 1 TO NOTE AND LOAN MODIFICATION AGREEMENT (this "Agreement") is made and executed this _____ day of July 2014, effective July 13, 2014, by and among PRESERVE EQUITY, LLC, a Minnesota limited liability company ("Borrower") and JAMES S. HALVERSON, CLINTON T. BLAISER, PRESERVE MANAGEMENT, LLC, a Minnesota limited liability company and HALVERSON AND BLAISER GROUP, LTD., a Minnesota corporation (collectively "Guarantors") and COMPASS TRADING COMPANY, LLC, a Florida limited liability company ("Lender").

WITNESSETH:

- 2. <u>Modification</u>. The Note is hereby modified as follows:
 - a. Paragraph 1(d), "Maturity Date", in the Note is hereby deleted in its entirety and replaced with the following: "Maturity Date" shall mean December 31, 2015.
- 3. <u>All Other Terms Unaffected</u>. Except as specifically modified by this Amendment, all other terms of the Loan Documents survive and shall continue to govern the parties.


