ORDERED AND ADJUDGED as follows:

1. Service of process has been properly made upon Defendant on MARCH 18, 2010.
2. Plaintiff has established by competent proof in the form of the allegations of the complaint, and invoices and affidavit of indebtedness which were attached to the complaint in the amount of \$112782.11, plus costs, prejudgment interest and attorney's fees.




